Donna Limiti, Director Region IV

•\$10 million statewide for residential services for individuals living at home.

•Stakeholder groups consist of parents, city representatives, self-advocates, housing navigator from Innovative Resource Initiatives, Inc.

•The Residential Request List which was called the Certified Residential Opportunity (has a new name)

•DQI had a training on the Redesign Annual Survey. The survey will address: (1) All waiver services an individual is involved with; (2) Agency review; (3) Policies & Procedures

•Auspice changes: CCNS will no longer be providing residential and day services for CP NY State. They will only provide Family Support Services.

•Human First, Inc., has a new Executive Director. UCP will be providing management assistance.

•Independence Residences Inc., (IRI) & Queens Parent Resource Center (QPRC) have merged and become Innovative Resources and Initiatives.

•CAS-new instrument to replace the DDP2 is a more comprehensive tool that will help in establishing funding for each individual.

•HCBS amendment addresses the initiatives in the Transformation Plan.

•As we look toward the future, Conflict Free Case Management will allow individuals case management services separate and distinct from residential, day services, etc.

•RFP will be coming soon for entities that want to develop an agency to provide case management services.
