- 1. MaryGrace Guiliano, Director could not be here today.
- 2. CCO transition was for the most part successful—OPWDD meets with the CCO leaders weekly to assist with trouble shooting some of the issues such as access and document upload.
- 3. Regional Office is currently down 2 Deputy Directors. The boroughs are being covered by the community Support Liaisons with the support of the Regional Director. Actively engaging in appointing candidates.
- 4. The Family Support Advisory Council will be meeting on September 20, 2018.

- 5. Get together awareness campaign. In the spirit of togetherness and community integration, OPWDD is launching the Get Together awareness campaign, which aims to promote unity in the community. Inspired by the 1060's song of the same name. Get together is about encouraging people to come together to achieve full community inclusion for everyone.
- 6, You can participate beginning today in a number of ways. Like OPWDD's Facebook page and add People Power frame to your profile. Like and share OPWDD's "get Together" video featuring the band Flame on social media.
- 7. Draft NYS Medicaid managed Care organization I/DD transformation requirements and standards to serve individuals with Intellectual and/or Developmental Disabilities in specialized I/DD plans—Provider Led (SIP's-PL) On July1, the Office of people With Developmental Disabilities, (OPWDD) took the first step in this transformation and transitioned to an improved way of coordinating services through the establishment of health Home Care management provided by Care Coordination organizations. Today we begin the movement to the second phase of OPWDD's transformation—the development of specialized Managed Care. OPWDD has posted for public comment a document that contains the requirements for the creation of specialized Managed Care Plans to coordinate and deliver all of an individual's services, including OPWDD-funded services, healthcare, behavioral health and medication management which can be found at: https://www.health.ny.gov/health.care/medicaid/program/medicaid health homes/idddraft idd 1115 waiver.htm.

I.A.C. Report: Richard Bosh

- DSP week was last week, many providers held special events to acknowledge our Direct Support Professionals.
- OPWDD recently issued draft regulations regarding the Eligibility for Services Regulations Part 629. While the first read of the draft regulations may not have raised red flags for many, the inclusion of a new section, "(b)(3)" re-review an individuals' eligibility at any time", did raise concerns. IAC will continue to work with OPWDD to ensure rights are protected.
- Standard Occupational Code for DSP's is the only information available to track labor trends. Accurate data can help make the case for changes needed to reduce the shortage of DSP's. More information to come on this initiative.
- Advocacy Initiatives: This year's continued initiatives are:
 - o #bFair2DirectCare supporting a "living wage" for our direct care staff
 - o #OurkidsareYOURkids ensuring the sustainability of our 4410 preschool and 853 school age programs.
- NYC announced in August that it needs more than 700 preschool special education seats on top of the 744 seats needed which was reported in April 2018. The report reflects the inability of preschool special education providers to respond to the regional need request due to inadequate funding of preschool special education services and their inability to recruit and retain certified teachers and teacher assistants.
